## Assessment of potential for further research and archaeological investigation

**Moderate to High**: There is significant potential for further documentary research on the development of orchards and the orchard industry in Burghill parish, aided by a large quantity of historic documents (including deeds and sale catalogues) and maps chiefly held at the HRO.

The Land Valuation field books for Burghill parish (held at the NA) provide a valuable snapshot of the extent and type of orchards planted and also often list buildings associated with cider/perry production. Local newspapers dating back to the late 18<sup>th</sup>/early 19<sup>th</sup> century also contain a great deal of information on orchards and buildings and equipment associated with the orchard industry.

Relatively few sites of archaeological interest associated with orchards have been identified within Burghill parish; some sites appear to have been impacted by modern farming practices (eg. a possible moated site located in an orchard W of Burghill church (PRN 6292), largely destroyed by the early 1970s), consequently the potential for further fieldwork in this area has been assessed as moderate, although there is possibly potential for field investigation of earthworks adjacent to Tillington Court, which may contain the remains of 16<sup>th</sup>-17<sup>th</sup> century garden features
